AUDIT FINDINGS

Narrative:

The audit of Winner Jail with a work release center in Winner, South Dakota was conducted on December 14 and 15, 2018 by Candy Snyder, a Certified PREA auditor and assisted by Mark Snyder, an auditing assistant.

An entrance meeting was held with facility staff Chief of Police Paul Schueth and Jail Administrator, Lori Kalenda. We then conducted a facility tour. The auditor then began interviewing specialized staff. Private accommodations were made for the auditor to conduct interviews. The Jail Administrator provided a listing of all inmates and the auditor randomly selected 20 inmates ensuring one from each housing area. There were no hearing/visually impaired inmates, non-English speaking nor inmates who identified as lesbian, gay, transgender or intersex. The auditor interviewed one inmate who reported sexual abuse. The auditor was provided a shift roster and randomly selected staff to interview from all shifts. It is important to note that staff rotate through all shifts. The auditor was not limited in any way from speaking with staff or inmates or inspecting any area of the facility. All staff were extremely polite and accommodating throughout the audit. On the day of arrival there were 127 inmates – 109 male and 18 female.

In addition the auditor reviewed employee files, training files, and investigative files. An exit briefing was held with the Chief and the Jail Administrator. The auditor provided a preliminary finding of each standard with the caveat that this was subject to change as the auditor continued to review documents, may have questions to be answered and prepares the interim report. The auditor thanked them for their hard work and their commitment to follow the Prison Rape Elimination Act.

The work release center was undergoing building changes and therefore there were no work release inmates in the facility during the initial on-site audit. In December the auditor toured the building under construction and reviewed the plans for the work release component of their jail with the Chief and the Jail Administrator. On May 5, 2019 the auditor returned to the work release center as the construction was complete and they were accepting work release inmates. There were two work release inmates in the facility and both were interviewed at that time as well as the Jail Administrator and the staff member assigned the primary duty of overseeing supervision of the work release center.

AUDIT FINDINGS

Facility Characteristics:

The Winner Jail is located in Winner, South Dakota. The building use is shared by the Winner Police Department, the Winner Dispatch Center, the Winner Jail and the work release program in the adjoining building. The jail includes an intake vehicle sally port and booking area, an indoor recreation area, the medical area, two classrooms, a kitchen, two staff offices, laundry and the housing units that surround a central control room. The recreation area is a large area with two universal-type exercise stations and a large basketball court. The recreation area is monitored by two cameras. All inmates are offered an hour of physical activity each day.

There are six housing units designated as A100, A200, B100, B200, C100 North and South and two holding cells. Housing Unit A100 is an open sleeping bay for general population male inmates with a 34 wall that separates the housing area from the toilet and shower area. There are eight triple bunks allowing for a maximum capacity of 24 inmates within this unit. Within the bathroom there are three private shower stalls with shower curtains, two toilet stalls and a urinal. Housing Unit A200 has eight cells that each contain three beds allowing for a maximum capacity of 24 male inmates within this unit. However, due to the population levels they have only been placing a maximum of two to a room. There is an internal dayroom and restroom with two private shower stalls with curtains. There is a combination toilet/sink in each of the cells. This unit is used for disciplinary segregation, to monitor inmates on closer observation due to suicidal behavior and inmates on lockdown status. Housing Unit B100 is an open sleeping bay for general population male inmates. There are eight double bunks and a sled bed for a maximum capacity of 19 inmates. There is a 3/4 wall that separates the two toilet stalls from the housing area. There are two private shower stalls with curtains. Housing Unit B200 houses female inmates and has five cells with three beds and three beds in the dayroom allowing for a maximum capacity of 18 female inmates. The cells have a combination toilet/sink. There is one private shower with a shower curtain. Housing Unit C is an open dormitory for male inmates with 11 double bunks allowing for a maximum capacity of 22 male inmates. It has a 3/4 wall separating the housing area from the toilet and shower area. There are three toilets and three private shower stalls with shower curtains in the bathroom. The basement has two units. The North and South units house state inmates only who are minimum security, many on trustee status. There are three separate rooms with open sleeping bays; a dayroom and a private restroom with a toilet, sink and shower. The Winner Jail houses minimum, medium and maximum security inmates. All Inmates are housed based upon needs and their respective level of classification. All inmates are supervised by three shifts of correctional officers.

The Winner Law Enforcement Center has plans to construct an addition to the eastern end of the building. This addition will add East100 that can house up to 30 inmates and East200 which can house up to 20 inmates. In addition, units A100 and B100 will be modified from open sleeping bays to small individual cells to allow more options and better separation of inmates by classification, segregation and/or observation purposes.

The work release center is adjacent to the jail. It is compromised of a dayroom with kitchen, laundry

facilities, and separate male and female housing areas. The female housing area has four private rooms. The male housing area has ten private rooms. Each housing area has a restroom with private toilet stalls, sinks and private shower stalls.

All units have closed circuit visit terminals within their housing unit that connect inmates to similar terminals in the visit area outside of the secure jail (on the Winner Police Department side of the building). An audit poster with auditor contact information was posted in the units as well as a Federal Marshall's posters on how to report sexual abuse for U.S. Marshall's inmate. All units had adequate camera coverage and an intercom that rings directly to the control room operator if immediate assistance is needed. Jail staff check every housing unit on rounds at a minimum of twice each hour. The audit team directly witnessed rounds being conducted consistently. The inmates that are in segregated or isolated housing away from other inmates were not there for protection from sexual assault or harassment or for reporting sexual assault or harassment.

AUDIT FINDINGS

The Winner Jail began implementation of PREA compliance measures over three years ago. An initial audit was conducted on May 20 and May 21, 2016. During the initial on-site portion of the audit the auditor identified several areas that needed addressed in order to meet the standards. The auditor began work over the corrective action period to assist the facility in achieving compliance with all PREA standards. However, the PREA Coordinator took an extensive personal leave of absence toward the end of the corrective action period. This unexpected absence meant that we were unable to achieve compliance before the corrective action period ended. Once the PREA Coordinator returned to duty she continued working on meeting each standard. Once much of the work was done, we re-scheduled this audit.

STANDARDS REQUIRING CORRECTIVE ACTION:

Standard 115.22 Policies to ensure referrals of allegations for investigation

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required that the investigative policy be posted on the jail's website following corrections. The auditor required the investigative policy be corrected to provide guidance to staff with specific language that both in policy and practice an administrative or criminal investigation is completed for all allegations of sexual abuse and sexual harassment by trained investigative staff. It is acceptable to train an Administrative Investigator so that they may make the decision to handle all non-criminal investigations and forward all potential criminal investigations on to the criminal investigator at the Winner Police Department. The Winner City Jail changed their policy to refer all sexual abuse and sexual harassment allegations to the Jail Administrator. The Jail Administrator is the administrative investigator for the facility and on February 14, 2019 completed the National Institute of Corrections on-line investigation course "PREA: Investigating Sexual Abuse in a Confinement Setting". An investigator from the Winner City Police Department is assigned to conduct any potential criminal investigations. He also completed the NIC course on February 15, 2019. The auditor verified that the investigative policy was posted on the Winner City Jail website.

Standard 115.31 Employee training

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required the jail develop a formal PREA curriculum on the specific 11 points outlined in the standard and provide this to the auditor. In addition, the auditor required the training forms signed by all staff that acknowledges that they received the training on those points and they understand both the policy and the training. The jail took a multi-faceted approach to staff training to include using parts of the PREA Resource Center training

curriculum developed by the Moss Group, some handouts and some one-on-one training provided by the PREA Coordinator. They provided the auditor signed training forms acknowledging receipt and understanding of the training.

Standard 115.32 Volunteer and contractor training

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required that the jail develop a formal PREA curriculum for their contractors and volunteers that can be tailored to the level of contact a contractor or volunteer may have with an inmate. In addition, the auditor required forms signed by contractors and volunteers working in the facility. The auditor provided specific examples such as the food service worker and the nurse who work independently with the inmates and should participate in training at the same level as the officers and should sign receipt of that training. However, the chaplain is always accompanied in the facility by a staff member and his training could be a verbal one-one-one training that outlines the zero-tolerance policy and how to report an incident of sexual abuse and sexual harassment, provide the zero-tolerance pamphlet and then sign receipt of that training. The jail has not had any religious volunteers or contractors enter any portion of the jail where inmates are housed during the corrective action period. The PREA Coordinator will provide training and obtain signed training forms for contractors and volunteers if this occurs in the future. The facility provided training forms for the nurses and the food service worker.

Standard 115. 33 Inmate education

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required the jail to provide an inmate roster on a date selected by the auditor during the corrective action period. The auditor then chose random inmates and the facility provided the documented training forms.

Standard 115.34 Specialized training: Investigations

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required documented evidence that all investigators have participated in a PREA related training such as the National Institute of Corrections on-line investigation course "Investigating Sexual Abuse in a Confinement Setting". The Jail Administrator provided the documentation that she completed the NIC course on February 14, 2019. The criminal investigator from the Winner City Police Department is assigned to conduct any potential criminal investigations and provided documentation that he completed the NIC course on February 15, 2019.

Standard 115.35 Specialized training: Medical and mental health care

CORRECTIVE ACTIONS: In order to be compliant with this standard, the auditor required the Winner Jail provide documented evidence of the nurse's participation in employee PREA training. This documentation was provided to the auditor as requested.

Standard 115.41 Screening for risk of victimization and abusiveness

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required that the jail provide an inmate roster on a date selected by the auditor during the corrective action period. The auditor chose a random sample of inmates and the facility provided completed documented screening forms.

Standard 115.42 Use of screening information

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required the jail to provide an inmate roster on a date selected by the auditor during the corrective action period. The auditor chose a random sample of inmates and the facility provided the documented screening forms that are complete with both the potential victim section and the potential perpetrator section. The top of each form identified

the outcome of the screening. This information was used to make the appropriate housing and work assignments.

Standard 115.54 Third-party reporting

CORRECTIVE ACTIONS: In order to meet this standard the auditor required the Winner Jail provide information on their website regarding how an individual can make a third party report of sexual abuse. In addition, the auditor recommended that the jail display posters in the lobby and visit area with this information. The information must include contact information for both internal and external methods of reporting sexual abuse. The auditor verified that the third party reporting information was posted on their website.

Standard 115.61 Staff and agency reporting duties

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required that this policy section be corrected to provide guidance to staff with specific language that all allegations of sexual abuse and sexual harassment be reported to trained investigative staff. The jail provided to the auditor their corrected policy that ensures staff report all allegations to the Jail Administrator. She makes the determination based on her experience and training as to what the next steps will be.

Standard 115.87 Data collection

CORRECTIVE ACTIONS: In order to meet this standard the auditor required the Winner Jail aggregate their data for the past three years based on the PREA Standard definitions of sexual abuse with the defined type of outcome ie.; substantiated, unsubstantiated, and unfounded. The jail provided the auditor their aggregated data report form.

Standard 115,88 Data review for corrective action

CORRECTIVE ACTIONS: In order to meet this standard the auditor required that the Winner Jail review their aggregate data, past incidents and complete all aspects of the annual review process as outlined within the standard. Following the annual review, the auditor required they complete an annual report and post the annual report on their website at http://www.winnersd.org/jail.html. The auditor verified that the annual report was posted to the website.

Standard 115.89 Data storage, publication and destruction

CORRECTIVE ACTIONS: In order to meet this standard the auditor required that the Winner Jail post their aggregate data for 2016, 2017 and 2018 on the jail's website http://www.winnersd.org/jail.html. The auditor verified that the aggregate data was posted to the website.

CORRECTIVE ACTIONS: In order to meet this standard the auditor required the jail post on its website the first audit that was issued. The auditor verified that this audit was posted on the website.

The Police Chief and Jail Administrator are firmly and earnestly committed to do whatever is necessary to implementation and following all PREA standards. The facility culture was strong and supportive in providing a safe environment for all inmates. This was verified through review of policy, direct observation and interviews with inmates and staff. |

| | The auditor interviewed the Chief, the Jail Administrator (also PREA Coordinator), staff and inmates. In addition, the auditor reviewed schedules, staffing plan, log books, and viewed the camera coverage within the control room. There is stability within their staffing and many staff have been with the facility for many years. They have strong, consistent leadership and a positive culture. Currently the jail has one jail administrator, five supervisors and 17 Corrections Officers. There are always, at a minimum, four direct care staff on duty 24 hours each day. Within the same building there is the 911-dispatch center and the Winner Police Department. Communications within the jail are monitored by the dispatch center and if an emergency exists, dispatch immediately contacts law enforcement for support. The control room has a direct view into the main jail housing areas and monitors cameras within all housing areas. The adjacent work release area is viewed by cameras as well as staff who conduct frequent rounds. The cameras and the call system are continually monitored. Unannounced rounds are conducted by intermediate and higher level supervisors as required by the standard. Rounds reviewed by the auditor included a variety of shifts and days of the week to include early morning, late evening and some weekends. |

The Winner Jail trains security staff in how to conduct cross-gender pat- down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. Staff stated during interviews that male staff only pat-search female inmates during limited, exigent circumstances. All staff were able to demonstrate use of the back of the hand to conduct a |
| | The facility has procedures that enable inmates to shower, perform bodily functions, and change clothing without staff of the opposite gender viewing except in exigent circumstances or when such viewing is incidental to routine cell checks. Inmates shower in private shower stalls with shower curtains to provide privacy and to prevent observation by staff of the opposite gender or casual observers. Some sleeping rooms have toilets within the room and the room is viewable by camera. However, the cameras have been blurred for privacy. In the female unit, the inmates typically place a towel over the window on their door when they are using the toilet and staff respect this procedure for privacy. Staff make a general comment immediately upon entering such as "Good Morning Gentlemen" or "Mealtime" so that the inmates are aware of their presence and given the opportunity to cover up. |

The auditor verified services through a call with the Winner Resource Center. The auditor interviewed the investigator from the Winner Police Department. 115.22 Policies to ensure referrals of allegations for investigations

Auditor Overall Determination: Meets Standard

Auditor Discussion

As soon as the Jail Administrator is notified of a sexual assault the protocol is to call the investigator from the Police Department. The investigator conducts prompt and thorough investigations of all allegations of sexual abuse that are reported to him. He has law enforcement authority to conduct investigations concerning any allegation of criminal action. The policy outlines the investigative procedures at the Winner City Jail. However, currently the policy states that if staff believes, more than 50% that something has happened, then it is enough to generate a report. The report is then followed up by the Assistant Jail Administrator or Supervisor who conducts an initial investigation. If they believe the incident happened, they then forward the report to the Jail Administrator. If the Administrator believes the incident occurred, the report is forwarded to the investigator. This policy adds too many decisions by personnel not trained in investigative procedures. All reports should be forwarded to the proper investigative authority to determine if the incident happened. Either the trained Administrative Investigator or the Criminal Investigator are the only personnel that should determine the outcome as Substantiated, Unsubstantiated or Unfounded. The policy is not posted on the facility website.

CORRECTIVE ACTIONS: In order to comply with this standard the auditor required that the investigative policy be posted on the jail's website following corrections.
